



Application for NAATP Board of Directors

Thank you for your interest in serving on the NAATP Board of Directors. NAATP is a national nonprofit professional membership association and trade organization of and for substance use disorder treatment providers. NAATP membership is comprised primarily of licensed and accredited treatment providers. Non provider entities that support recovery and support treatment programs are also members of the association in the categories of supporter member and affiliate member. Founded in 1978, the mission of NAATP is to provide leadership, advocacy, training, and member support services to ensure the equitable availability and highest quality of addiction treatment. NAATP itself also serves as the sole corporate member of the NAATP Foundation for Recovery Science and Education.

The NAATP Board of Directors serves as the associations governing body providing oversight and vision for the association. NAATP operations are conducted by a professional staff headed by the NAATP Chief Executive Officer. NAATP Board members serve without compensation as association volunteers. NAATP Board members further support the organization by assuming their NAATP related expenses and supporting NAATP activities as sponsors.

The NAATP Board is comprised of 22 – 25 members of which 18 must be chief staff executives (CEO, President, Executive Director) of an addiction treatment provider. Board members serve three-year terms and may be eligible for additional terms. Two NAATP Board seats are reserved for supporter members of the association.

NAATP Board members are elected by the NAATP Provider Members from a slate of candidates presented by the NAATP Nominations Committee. Candidates are considered for service based on their education, training, experience, and expertise, understanding of the NAATP mission and values, and a demonstrated dedication to the association and/or the field at large. NAATP Board Members must adhere to and support the NAATP Mission, Vision, Values, the NAATP Quality Assurance Guidebook, the NAATP Code of Ethics, and the NAATP Public Policy Statement.
